Previously, Dr. Hayes was as Team Lead in CDC's Global Noncommunicable Diseases Branch where she played a critical role in the development and implementation of the Global Hearts Initiative, a strategic approach to reduce and control cardiovascular diseases globally. Dr. Hayes hold a bachelor's degree in accounting from St. Joseph's University in Philadelphia and received a master's degree in economics and Doctor of Public Health from Georgia State University in Atlanta.

He has academic interests in public health services frameworks (e.g., Foundational Public Health Services), collaborative service delivery (i.e., crossjurisdictional or cross-sectoral collaboration), and other transformation and innovation initiatives for public health systems.

### Staffing Up Public Health: Methodological, Financial, and Practical Considerations

Mac McCullough is associate professor and director of public health agency partnerships at the Boise State University School of Public and Population Health. His research involves examining investments in public health and social services and assessing how these investments improve population health. He co-created a data source to track spending on health and social services at the local level and has used these data to explore how community spending can influence health factors and outcomes. His teaching centers on finance, policy, and management in health care and public health. He was named a "40 Under 40 in Public Health" leader by the deBeaumont Foundation and, until 2022, was associate professor at Arizona State University and health economist for Maricopa County Public Health.
